LCU actual performance on 16 measures in 3 clinical domains was compared to expected performance, if the LCU performance were at either the national Quality Compass 90th percentile or 75th percentile. If the actual rate combining all measures in the domain is greater than the expected rate at the QC rates, the LCU earns points: 2 points for exceeding QC90 and 1 point for exceeding QC75. LCUs earning >=4 points earn Honor Roll status. LCUs earning the maximum 6 points earn Honor Roll with Distinction status.
